

T&C'S - MEMBERS NIGHT

These Terms and Conditions ("Agreement") govern your participation in the "Members Night Jackpot" (the "Jackpot") hosted by Diggers & Sports Club ("the Company"). By participating in the Jackpot, you agree to comply with these Terms and Conditions. Please read this Agreement carefully.

1. JACKPOT DETAILS:

- 1. The Jackpot is held every Thursday from 6pm.
- 2. The Jackpot starts at \$1,000 and increases by \$250 each week if not claimed.
- 3. Once the Jackpot reaches \$5,000, it will be a guaranteed giveaway on that specific Thursday night.
- 4. The prize for the Jackpot will be determined and announced by the Company.

2. ELIGIBILITY AND ENTRY:

- 1. All active Diggers & Sports Club members are automatically entered into the Jackpot each week.
- 2. Members must be present at the club on the night of the Jackpot to be eligible to win.
- 3. Non-members and guests are not eligible to participate in the Jackpot.
- 4. Staff and board members are not eligible to enter.

3. VIRTUAL DRAW:

- 1. There will be 3 draws each Thursday
- 2. The Jackpot draw will take place at approximately 7:30pm, 8:00pm and 8:30pm on the designated Thursday night.
- 3. The draw will be conducted as a "virtual draw" hosted by Odyssey.
- 4. The winner will be randomly selected during the virtual draw.

4. CLAIMING THE PRIZE:

- 1. The winner of the Jackpot has 3 minutes from the time their name is announced during the virtual draw to make themselves known to club staff.
- 2. If the winner fails to make themselves known within the specified time frame, the prize will be forfeited.
- 3. The Company reserves the right to redraw the prize until a winner is found, as long as time allows on the \$5,000 guaranteed night.



5. ADDITIONAL TERMS:

- 1. The Company reserves the right to modify, suspend, or terminate the Jackpot at any time without notice.
- 2. Any disputes regarding the Jackpot or its rules will be resolved at the sole discretion of the Company.
- 3. All decisions made by the Company regarding the Jackpot are final and binding.

6. GOVERNING LAW AND DISPUTES:

- 1. These Terms and Conditions shall be governed by and construed in accordance with the laws of the jurisdiction of Queensland.
- 2. Any disputes arising out of or relating to the Jackpot or these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts located in the jurisdiction of Queensland.
