

T&C'S - KIDS EAT FREE

These Terms and Conditions (the "Agreement") govern your participation in the Kids Eat Free Promotion ("the Promotion") offered by Diggers and Sports ("the Company"). By participating in the Promotion, you agree to comply with these Terms and Conditions. Please read this Agreement carefully.

1. ELIGIBILITY:

1. The Promotion is open to individuals aged 18 years or older who are legal residents of the jurisdiction where the Promotion is offered.
2. Employees of the Company cannot redeem this promotion within 30 minutes before or after their shift is due to start / finish are not eligible to participate in the Promotion.

2. KIDS EAT FREE PROMOTION:

1. Under the Kids Eat Free Promotion, customers who purchase a meal from the printed menu, with a value of \$19 or more, are eligible to receive one free meal from the kids menu.
2. The free kids meal is limited to one per main meal purchased.

3. REDEMPTION:

1. To redeem the Kids Eat Free Promotion, customers must order a main meal from the printed menu with a value of \$19 or more.
2. For each qualifying main meal purchased, one free kids meal from the kids menu may be selected.
3. The free kids meal cannot be exchanged or substituted for another menu item.
4. The Promotion is valid during the specified promotion period and at participating locations of the Company.

4. PROGRAM MODIFICATIONS AND TERMINATION:

1. The Company reserves the right to modify or terminate the Promotion, in whole or in part, with or without notice to participants.
2. In the event of Promotion termination, customers will have a reasonable period to redeem any outstanding free kids meal offers.
3. The Company may modify these Terms and Conditions at any time, and such modifications will be effective upon posting the updated Agreement on the Company's website or other communication channels. Participants are responsible for regularly reviewing these Terms and Conditions.

5. LIMITATION OF LIABILITY:

1. The Company is not responsible for any allergies or dietary restrictions related to the free kids meals. Customers are advised to inquire about ingredients and notify staff of any dietary concerns.
2. The Company is not liable for any errors, omissions, delays, or disruptions in the administration of the Promotion.
3. To the extent permitted by law, the Company shall not be liable for any direct, indirect, incidental, consequential, or punitive damages arising out of or in connection with the Promotion.

6. GOVERNING LAW AND DISPUTES:

1. This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction where the Promotion is offered.
2. Any dispute arising out of or relating to this Agreement or the Promotion shall be subject to the exclusive jurisdiction of the courts located in the jurisdiction where the Promotion is offered.
